



REGISTRATION GUIDANCE AND FEES FOR 2018 FOALS

Keep this document safe. By signing the Registration Application Form, you are confirming that you have read and understood this document, and accept the terms and conditions.

The forms used last year have not changed for 2018. If you use a pre-2016 form it will be returned.

Registration Fees (members' rates) up to 30 November 2018	Pure-bred £12	Part-bred/Equine £15
otherwise from 1 December 2018 (non-members rates double) ID-only passports available to members only	£24	£30

**We do not want any forms handed in at the December Beaulieu Road Sale.
All sale entries should be registered at one of the November meetings.**

Time scales

- Registrations are dealt with by the Registration Committee or Council at meetings as published in the 2017 Annual Report and the 2018 Commoners Calendar. Additional meetings may be held as necessary during peak times.
- Incorrect forms and/or inadequate diagrams or descriptions will be returned for completion by a vet or competent authority for which there may be a charge, and which will delay the processing of the registration and production of the passport.
- The last GP meeting at which Forest-bred foals will be registered is **14 November 2018. An extra registration meeting will be held at the end of November.**

Legal Requirements for Passports

- All pure-bred NF 2018 foals must be registered during 2018.
- Any foals not registered during 2018 will have to be DNA tested at a cost of £120 OR registered in the Unapproved Section of the Stud Book (The X-Register). The Society is also required to complete Part II of Section II of the passport, irreversibly removing the pony from the human food chain.
- **Foals born in 2018 must be microchipped before a passport can be issued.**

Derogation for Forest-Run Ponies

Regulation 18 and the Schedule of the Horse Passport Regulations 2009 make special provision for the ponies living under semi-wild conditions in the New Forest. These do not need to be identified with microchips/passports while they remain within the designated area. For full details of the registration procedures for Forest-run foals see the separate paper: **Guide to the Horse Passport and Microchipping Regulations 2009 as it Relates to New Forest Ponies**, available from the office, or on the website.

Registration Rules

- A pony is eligible for registration only if both its sire and dam are registered in the New Forest Stud Book and it complies with all current conditions, as set out in the Society Rules.
- The Council reserves the right to reject any entries tendered for entry into the Stud Book and all ponies must be open to inspection and DNA testing.
- The Society's Complaints Procedure is on the website.
- When the pony was sired on the Forest, fill in the Forest Sired section.
- Stud-bred foals: the dam's name must be on the Stallion Return, or a Covering Certificate must be provided.

- Only the breeder's prefix may be used. New prefixes must be approved by the Council and are subject to confirmation by the Central Prefix Register.

Completing the Registration Application Form

- The breeder is responsible for completing the form.
- If the foal is being sold or transferred at the same time, please note the additional transfer fee payable - £7.50 (members) or £15 (non-members).
- The ID sketch must be completed to an acceptable standard by a Society-approved identifier.
- The identifier must check the animal for other methods of identification (eg freeze or hot brands) and ensure that these are included on the sketch.
- The foal must then be microchipped: The vet will complete the ID sketch, or will confirm the sketch if appropriate. The vet will mark onto the silhouette the position of the microchip, having inspected the animal for evidence of a previously implanted chip. The microchip barcode sticker will be stuck in the space provided. If for some reason, a barcode sticker is not available, please write the chip number *very clearly* in the boxes provided. The vet will sign the form.

Fees and Postage

- The correct fee is required before the pony will be entered, please ensure it is enclosed and that you have completed the form and diagram correctly.

Do not forget the transfer fee, if applicable - £7.50 (members) or £15 (non-members).
- If you would like receipt of your application acknowledged, please enclose a stamped addressed envelope.
- Passports are valuable documents and the Society recommends the use of Signed For Delivery. Please add £3 if you wish your documents to be returned by Signed For Delivery. ☐

Legislation and Society Regulations

Registration of New Forest ponies into the stud book is regulated by 96/78/EEC and (EU)2016/1012, and policies are set out in the Society's Rules and the Conditions of Registration, and the introduction to the most recent volume of the published Stud Book. The current passport legislation is EC2015/262 and the 2009 Horse Passports (England) Regulations. The Society is bound to meet all legislative requirements.

NFPBCS will continue to process your personal data as part of its ongoing horse breeding database in accordance with horse passport legislation, until you notify NFPBCS to stop processing your personal data. To discharge its responsibilities for implementation of horse passports. To facilitate strategic planning within the equine sector. To assist in tracing the owners of straying, lost or stolen horses. To reduce malpractice in the sale of horses and ponies. All data as required by Defra will be uploaded to the Central Equine Database. The Society will also publish the data in the New Forest Pony Stud Book. The Society may also respond to requests from the Verderers of the New Forest in connection with the administration of their Higher Level Stewardship Scheme.
