To reduce malpractice in the sale of horses and ponies. All data as required by Defra will be uploaded to the Central Equine Database. The Society will also publish the data in the New Forest Pony Stud Book. The Society may also respond to requests from the Verderers of the New Forest in connection with the administration of their Higher Level Stewardship Scheme.
