

## VENDORS CONDITIONS OF ENTRY AND SALE FOR ONLINE BEAULIEU ROAD PONY SALES

In these conditions the term 'Auctioneers' refers to John Jeffery (Auctioneers) Ltd, trading as Southern Counties Auctioneers. The term 'Society' refers to the New Forest Livestock Society. The term NFPBCS refers to the New Forest Pony Breeding and Cattle Society and the term NFCDA refers to the New Forest Commoners Defence Association.

1. Entries are accepted for ponies of any breed for which marking fees have been paid in the 2021 year (or Dams of 2021 foals) as well as Registered & Part Bred/First Cross Ponies that are non-forest run. **All entries must be the bona fide property of members of the NFPBCS or the NFCDA.**

2. All ponies must have a full passport and matching microchip **prior to being entered into the online sale.** Passports must be listed in the correct and current ownership.

3. No foal will be accepted for sale under 4 months of age at the time of collection including those sold with their dams

4. No mare visibly in foal shall be entered for sale.

5. Description of sections at all sales

Section 1/2 - will be for Registered New Forest ponies for which the registration number must be included on the entry form.

Section 3 - will be for ponies entered into the New Forest X Register, first cross New Forest ponies and part breeds which are registered in the First Cross Register or part bred record. Details to be provided as for section 2.

Section 4 - will be for non registered horses and ponies including other breeds and crosses but complying with condition 1 & 2 above. ( NB As per point 1 above , entries in Section 4 can only be for ponies on which marking fees have been paid in the 2021 year, or dams for those that were foals in 2021 )

6. Any reserve prices must be made in writing and on the entry form, otherwise ponies will be sold to the highest bidder, subject to the minimum bid of **£50**

7. Commission will be charged at 5% (plus VAT). **Their will be an entry fee of £6 including V.A.T payable in advance when making your entry.**

There will be a buyer's premium of 6 % including V.A.T charged to the purchaser.

8. The Society, NFPB & CS and the Auctioneers reserve the right to exclude any pony from the sales without giving reasons and any decisions made by the Society or Auctioneers as to the conduct of these sales shall be final and binding at all times.

9. All required details must be completed on the entry form. Details of age, sex, colour, height and breeding will be included in the catalogue along with any registration number and the microchip number. **Any known vices should be noted on the entry form. Failure to do this may result in the cancellation of the sale of the pony.**

10. Vendors are responsible for the descriptions and details of the pony shown in the catalogue and the Auctioneers and the Society do not accept responsibility for any misdescription. Any recourse due to the purchaser due to a misdescription will lie solely between the purchaser and the vendor. All ponies will be deemed to be signed out of the Food Chain. If it is proven that the vendor has deliberately furnished false information or that any pony has had any treatment that affects its condition or behaviour in order to misrepresent its true condition or temperament the Auctioneers withhold the right to annul the sale at their own discretion.

11. For geldings, the passport must have been amended from colt to gelding. No castrated colt/stallion (irrelevant of age) should be presented for sale until at least 4 weeks post castration. Their passports must have all drugs given listed with withdrawal periods. The castration date should be entered in the passport and signed by the Vet. Any colt/stallion castrated within 6 weeks of the sale must have a certificate signed by the Vet indicating that the castrated colt/stallion has been checked post castration and that the wound has healed successfully.

12. All images supplied, both still and moving, must be a true picture with no photoshopping or enhancing of the featured equine. Any image supplied where the equine has been enhanced or manipulated will render the sale void

13. Any person riding an equine in an uploaded photograph must be wearing a hard hat of an approved British standard. Likewise, any handler under the age of 14 must also be wearing a hard hat of an approved British standard.

14. The name, Post Code and contact details of the vendor will be displayed in the catalogue. The vendor must sign the front of this form to confirm that they are happy for their details to be disclosed. These details will be available for prospective purchasers to arrange viewings and collections.

15. Any viewings prior to the sale, and collections, must adhere to the current government Covid guidelines. vendors must ensure that ponies are loaded safely onto the purchaser's transport. The Auctioneers and Society do not accept responsibility for any injury caused to either vendor or purchaser during the collection or viewing of the ponies. Vendors must ensure that ponies are loaded in the correct manner onto suitable transport to comply with the **Welfare of Animals (Transport)(England) Order 2006.**

16. Once a pony is entered and accepted for sale the vendor undertakes **not to sell the animal prior to the end of the online auction.** If a vendor is found to have broken this rule they will be excluded from future sales.

17. Vendors must wait for confirmation from the Auctioneers that payment has been received from the purchaser before arranging collection and must inform the Auctioneers when that collection has been made. Payment will be made 7 days after confirmation of the **last collection for that vendor.**

18. Transfer of the passport into the purchaser's name will be the responsibility of the purchaser who will bear the cost of transfer. It is a requirement under the Horse Passport (England) 2009 Legislation to register a change of ownership with the relevant Passport Issuing Organisation (PIO) within 30 days of acquiring a horse.
